

# **President's Message**



It looks like the public is trending towards not waiting for snow to install winter tires. The recently released Tire & Rubber Association of Canada Winter Tire Report shows that 65% of Ontarians make the switch to winter tires. Outside of Quebec, which has mandatory winter tire law, Canadians using winter tires has almost doubled since 1998. Good for us, great for safety. Let's hope that more catch on to Best Practice of installing winter tires at the optimal temperature of 7°C.

Speaking of best practices, have you reviewed your wheel installation procedures lately? I don't

know if there are more occurrences of wheel offs, or if there are more cameras out there, but our industry is getting a lot of Of note is the graphic press. video of a minivan losing its front left wheel posted on YouTube in November. The Ontario Safety League has called on the government to have all wheel technicians certified. We were contacted by government officials to get our position on this. We have always promoted best practices with our training programs. We Automotive two Tire have Service courses scheduled for the New Year. We are also working with the Ontario College of Trades to identify how to reach the new tire technicians with proper tire training.

The OPP have been collecting data specifically on wheel off incidents for several years. There is some interesting information in this study that will be released to the public in March. The OTDA is reviewing this data with MTO to create a strategy to lower the number of these incidents. You will see more on this in the coming months. You will see in this issue of Trends that at TRAC's Rubber Symposium, there was lots of discussion about the transition of Ontario Tire Stewardship to a new program. Bill 151 was proclaimed through an order in council in November, so reality is here. We are working on options for new proposals. Again, you will hear more on this in the coming months.

We are active on many fronts. If you want to get involved, let us know. I wish you all a Merry Christmas and prosperous New Year.





# Winter Tire Usage in Canada

Winter tire utilization has nearly doubled since 1998. At that time, 35 per cent of Canadian drivers used winter tires. By 2016, national usage had grown to 67.9 per cent. TRAC's 2016 national survey reveals that, outside Quebec, 61 per cent of the Canadian drivers are currently using winter tires, showing a very positive growth in the recent years.



A 2011 study by the ministère des Transports du Québec demonstrates the road safety benefits of legislating winter tires. After the first two seasons of enforcement (winter 2008-2009/2009-2010):

• Road accidents in winter decreased by five per cent.

• 574 fewer people were injured annually in winter road accidents.

• Deaths and serious injuries due to winter road accidents decreased by three per cent.

Winter Tire Incentives by Region

# Garage Liable for Crash Involving Vehicle Stolen from its Premises

On July 8, 2006 a 15 year old boy met up with his friends at the dam in Paisley, Ontario. Two of the boys shared eight beers that one of them had brought with him. One of the boys did not have any of the beer. The three boys walked to the 15 year old's house around 8:30 p.m. where the two continued to drink beer. The boy's mother had purchased a case of beer (24) for the boys to drink.

The mother went to bed prior to 11:00 p.m., leaving the boys unsupervised. They found a bottle of vodka later that evening and the boys drank vodka mixed with orange juice. They also shared a single marijuana cigarette. One of the boys went home later that evening and the other two left the house around the same time, setting in motion a series of events that ended with a crash and serious injuries to the boys friend.

The two boys walked around Paisley with the intent of stealing things from unlocked cars. They ended up at Rankin's Garage, which services and sells used cars and trucks. The garage property was not secured. They found an unlocked Toyota Camry parked behind the garage. The keys to the Camry were in the ashtray. The young male decided to steal the car even though he did not have a driver's licence and had never driven a car before. His friend got into the car as a passenger. The plan was to drive to the nearby town of Walkerton to pick up another friend. The car crashed on the way there. The passenger suffered a catastrophic brain injury.

The boy pleaded guilty to theft under \$5,000, dangerous operation of a motor vehicle causing bodily harm and possession of stolen property obtained by theft. A charge of driving with over 80 milligrams of alcohol in his blood was dropped. His mother pled guilty to a charge of supplying alcohol to minors. The friend was not charged with any criminal offences.

The trial judge instructed the jury that Rankin's Garage owed a duty of care "because people who [are] entrusted with the possession of motor vehicles must assure themselves that the youth in their community are not able to take possession of such dangerous objects."

The jury found the boy, his mother and Rankin's Garage negligent. The friend was found contributorily negligent. The jury offered the following comments:

• Rankin's Garage's negligence arose out of leaving the car unlocked; leaving the key in the car; knowing (or ought to have known) of the potential risk of theft; having very little security; and testimony inconsistencies.

• The mother's negligence arose out of providing alcohol to minors; failing to supervise minors; and failing to keep her own alcohol secure.

• The boy's negligence arose out of drinking underage; not having a driver's licence; stealing a car; impaired operation of a car; and trespassing.

• The friend's contributory negligence arose out of willingly getting into a stolen car; knowing his friend did not have a driver's licence; knowing that he was impaired; knowing that he was an inexperienced driver; and participating in stealing a car.

The jury apportioned liability as follows:

Rankin's Garage:	37%
Boys Mother:	30%
Son:	23%
Son's Friend:	10%



# New Jersey Assembly Helps Define Unsafe Used Tires

The New Jersey Assembly has left no doubt as to its view on unsafe used tires. By a vote of 72-0 on Nov. 21, it unanimously passed legislation to prohibit the sale of unsafe used tires that pose a risk to New Jersey motorists and the public.

The bill, A 3896, would impose a \$500 fine for a first offense on any business that sells a tire that exhibits any one of several unsafe conditions such as worn-out tread, visible damage, or improper repairs. Subsequent violations may be enforced under the state's Consumer Fraud Act.

The bill was introduced by Assemblywoman Shavonda E. Sumter (D-Paterson). It must now pass through the Senate to become law.

The bill is supported by the Rubber Manufacturers Association (RMA), the Tire Industry Association and the New Jersey Gas Station-C- Store-Automotive Association.


The National Highway Safety Administration says that wornout tires are three times more likely to be involved in a crash than tires with sufficient tread depth. NHTSA crash statistics indicate that about 200 fatalities and 6,000 injuries are attributed to tire-related causes annually.

RMA research shows that more than 30 million used tires are available for sale nationally each year.

According to the RMA, the legislation does not ban all used tire sales. It targets used tires that have specific, well-established, unsafe conditions.

"This is a common-sense, prosafety, pro-consumer bill," said Anne Forristall Luke, RMA CEO and president. "Preventing these unsafe used tires from operating on New Jersey roads will reduce the risk of crashes and save lives. It's that simple." Tires worn to 1/16th of an inch are considered worn-out and are dangerous because they no longer provide sufficient grip on the road, particularly under wet conditions. Tires with damage exposing steel belts or other internal components threaten a tire's structural integrity. Improperly repaired tires can suffer loss of inflation pressure or have hidden damage that may contribute to tire failure. Tires with bulges indicate possible internal damage that can lead to tread separation.

"We are grateful to Assemblywoman Sumter for her commitment and hard work to pass this legislation to improve motorist and highway safety," says Luke. "We also wish to thank Chairman Paul Moriarity (D-Turnersville) for his leadership in passing the bill in the Assembly Consumer Affairs Committee."

# Are OEMs In Europe "manipulating" TPMS tests?

Campaigning body Transport & Environment (T&E) has published research suggesting original equipment vehicle manufacturers are "again manipulating official tests – this time on safety by adjusting indirect tyre pressure monitoring systems (TPMS) to pass the lab test but failing to perform on the road".

T&E commissioned IDIADA to test a Volkswagen Golf and a Fiat 500L equipped with indirect TPMS to perform a copy of the type approval test carried at IDIADA, which they passed. But out of 16 realworld tests diverging from the official protocol, the Golf failed 14 and the Fiat all 16. Such indirect systems rely on tyre vibration and wheel rotations to detect low pressure, while direct TPMS has sensors to measure the pressure in each wheel.

Julia Poliscanova, clean vehicles manager at T&E, said: "With Dieselgate, carmakers were caught wilfully putting the public's health at risk from poisonous emissions. Now we find manufacturers could be deploying similar defeat devices to get ineffective tyre pressure monitoring systems to pass safety tests and save themselves 10 euros. Investigations of the suspicious TPMS performance must be carried out. Our tests clearly show that the unsafe indirect systems put drivers, pedestrians and cyclists at greater risk of dangerous blow-outs."

According to T&A, the most suspicious results were obtained when the same regulatory test was repeated on tyres with some mileage – here the TPMS failed to alert drivers of tyres' low pressure. T&E's reading of the situation is that this "indicates that the indirect systems were primed to get through official tests but become less sensitive once they were used on the road....Carmakers may be optimising indirect systems to be less sensitive after the initial test as their detection is based on wheel vibrations and rotations which could be falsely triggered in various real-world conditions like varying road surfaces and temperatures, and cold or slippery weather." Another reading of it is that such systems are simply less precise as tyres wear.

Currently, EU law mandates TPMS but doesn't differentiate between direct and indirect systems. T&E said that the review of the inadequate performance criteria, as part of the new General Safety Regulation (GSR), should only allow direct systems. The new GSR, set to be proposed by the end of this year, should also require more onroad testing of cars to check their safety performance.

Julia Poliscanova added: "The EU has a unique opportunity to phase out this ineffective safety equipment in its upcoming review of the General Safety Regulation and mandate that TPMS should perform in real-world conditions and with all tyres, including replacement ones. The European Commission should also use current negotiations on the new Type Approval Framework Regulation to ensure tyre pressure monitoring systems are checked over their lifetime on the road by the national market surveillance authorities and the Commission."
